### **CSA Management Committee Members**

Thank you for considering becoming a CSA management committee member.

The CSA management committee can have up to 23 members (including 3 office bearers). A person can only be a committee member if he or she is a current member of the CSA (membership for the CSA is from January to December each year). This includes nominees under corporate members.

A management committee member's term is for one year, from the AGM in which he or she is elected to the following AGM each year (the AGM is usually in March). If you wish to remain on the committee, you will need to re-nominate.

In order that you understand the workload of a Committee member, it is expected when joining the management committee of the CSA that you will be able to:

- Attend CSA management committee meetings (generally these take place every 6 weeks (9 in total), but there may also be ad hoc meetings from time to time). In addition, the CSA does much of its work through subcommittees, and you will be expected to contribute to the work of those committees from time to time
- Contribute to the organisation of CSA functions – Example, provide ideas for seminar topics, source speakers, chair the seminar or hosting the seminar at your organisation
- Contribute to the organisation of the biennial copyright symposium – For example, providing ideas for symposium sessions, sourcing speakers and chairing a session
- Contribute to the strategic planning and organisation of the CSA
- Contribute to the Copyright Reporter
